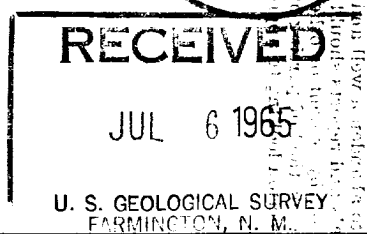
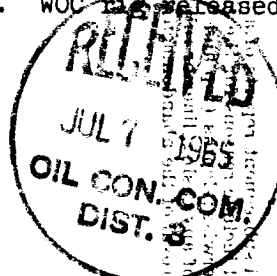

Cement first stage with 150 sacks cement, second stage through collar with 1300 sacks cement, 175% excess cement used. WOC released 6-15-65 wait on completion rig.
