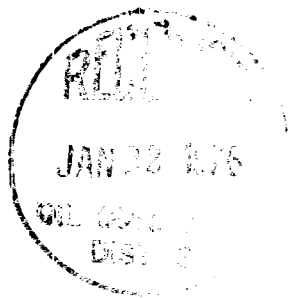

Instructions
