DETAILS OF WORK

In August 16, 1951, at 7:00 a.m., 5-1/2" casing was landed at 100 feet with 75 sacks cement. Rotary rig was moved off location and cable tool rig rigged up for drilling cement plug and cap. On August 21, 1951, hole was bailed dry and remained dry for two hours. Thirty-six feet of solid cement was then drilled in bottom of hole and hole again bailed dry. Hole remained dry for two hours and was considered a satisfactory water shut-off test.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
