4/27/86 MIRUSU. POOH w/1-1/4" tbg and 2-7/8" pkr.

4/28/86 MIRUSU. NDWH. NUBOP. Released pkr and COH w/tbg and pkr. RIH w/tbg and overshot. Latched onto the tbgs sub. Pulled up, RIH w/wireline cutter. Cut the 1-1/4" tbg @ 2080'. POOH w/tbg and fish. RIH w/wireline set CIBP. Set the BP @ 2075'. POOH w/tbg. RIH w/free-point tool. Freepointed 2-7/8" @ 1250'. PU and made a cut @ 1200'. Pull 12,000# over when the cut was made. Tbg did not come loose. Worked for 1-1/2 hrs. Can circulate down the tbgs, up the bradenhead, or down the bradenhead, up the tbgs, but we could not get the tbgs out. Run back in hole w/cutter. Cut it @ 1150'. Pulled 70,000 over, tbgs still not come free.

4/29/86 Pump 350 sx Class B cmt down the csy, out the surface to the bradenhead. Had good cmt returns @ the bradenhead. Closed the bradenhead and put 25 more sx into formation. Maximum pressure @ the tail end of the squeeze = 150#. Verbal approval for the change and the plug and abandon procedures from BLM office by Steve Mason.
