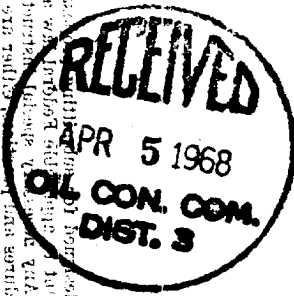

3-24-68 Ran 95 jts 1" tubing, landed 1995'. Rigged down unit. Put well back on production 3-27-68.
