

DETAILS OF WORK

It is proposed to drill a Pictured Cliffs gas test to a total depth of approximately 2144'. Approximately 100' of 10-3/4" surface casing will be used and cement circulated. Approximately 2090' of 7" casing will be set 5' into the Pictured Cliffs sandstone with the use of rotary tools and cemented with 100 sacks. Cable tools will be used to drill the Pictured Cliffs sandstone. The well will be shot with approximately 200 quarts of SAG, and the well completed in the usual manner.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.


