DETAILS OF WORK

J. C. Davidson "H" Well No. 1. We propose to drill the above well to an approximate total depth of 6700' with rotary tools to evaluate Dakota prospects. Stimulation and completion will be as indicated upon reaching total depth.

The following casing program is proposed:

First stage 6% gel followed by 100 sacks neat. Second stage 4% gel. Casing will be cemented by 2-stage method with DV tool set approximately 100' below Pictured Cliffs. First stage will consist of sufficient cement to fill 500' above top of Gallup. Second stage will consist of sufficient cement to fill 200-300' above Pictured Cliffs. Copies of location plat are attached. A copy of any survey taken will be submitted upon completion of well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

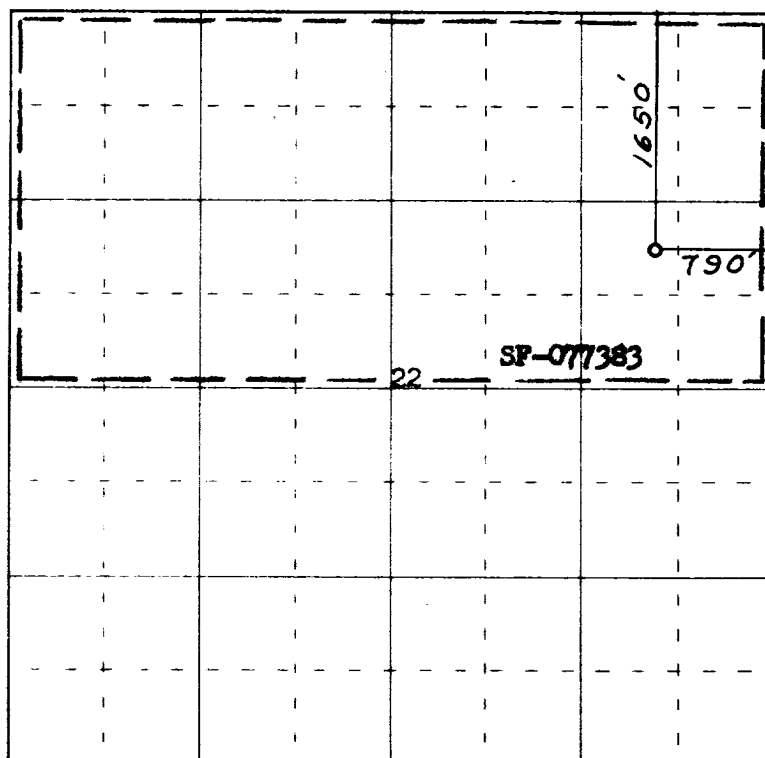

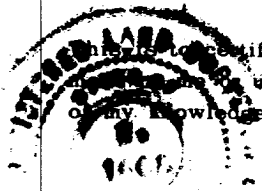
