Reference is made to your application for approval of an unorthodox well location for your McClanahan Well No. 10 located 990 feet from the North line and 1980 feet from the West line and in the NE/4 NW/4 of Section 24, Township 28 North, Range 10 West, Antec-Pictured Cliffs Pool, San Juan County, New Mexico.
