Perf'd at 1104' w/4 jspf, .340 inch diameter, 120 degree phasing, 12.5 grams, total 4 shots fired.

Squeeze perfs with 137 sxs Class B cement. Pumped ^{Cement} ~~water~~ down casing circ out BH to surface.

Cutoff wellhead, top off casing, and install marker. RDMOSU 2/9/96.
