This is in response to your 3-25-94 letter: This well has produced a total of 498 MMCF. The low flow rate prior to shut in and steep production decline of this well indicates little potential exists for restoring production. This well is in a fair location for development of the Fruitland Coal horizon in this section. We will either recompleting this well to the Fruitland or abandon this well in 1994. We are asking for continued shut in status until analysis of recompleting to the FT formation is complete.
