The above well was perforated on November 13, 1972, 2155-66, 2172-82 with 2 SPP. On November 14, 1972, 300 gallons of 15% HCl was spotted and displaced. Break-down pressure 1550 psi. Sand-water fraced with 35,000 gallons water treated with 12 KCl and 10 lbs. Gel per 1,000 gallons, 5,000 pounds 20-40, 20,000 pounds 10-20, and 10,000 pounds 8-12 sand. Treating pressures: Maximum 2200 psi, minimum 1500 psi, average 1800 psi. AIR 62.5 BPM.
