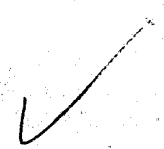

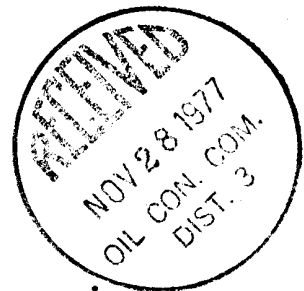

casing with 150 sax cement if appears productive. Will perforate and test.

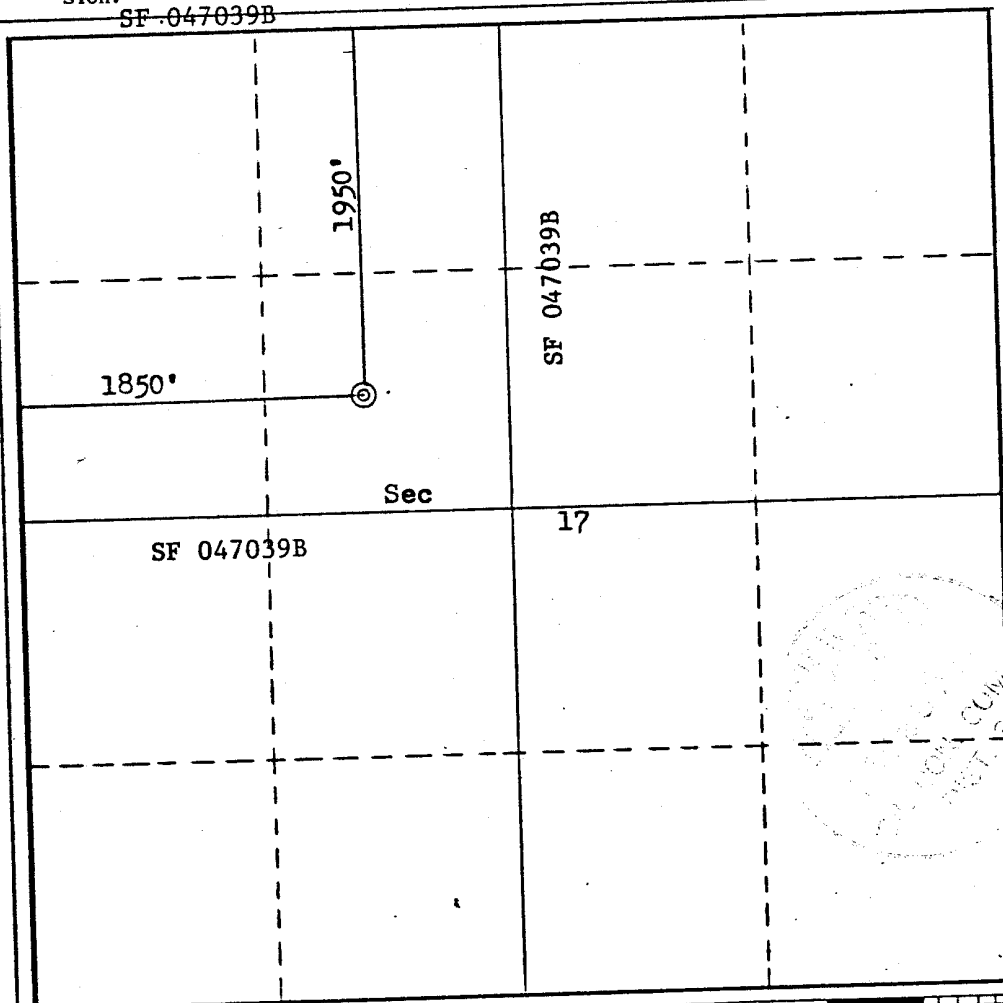

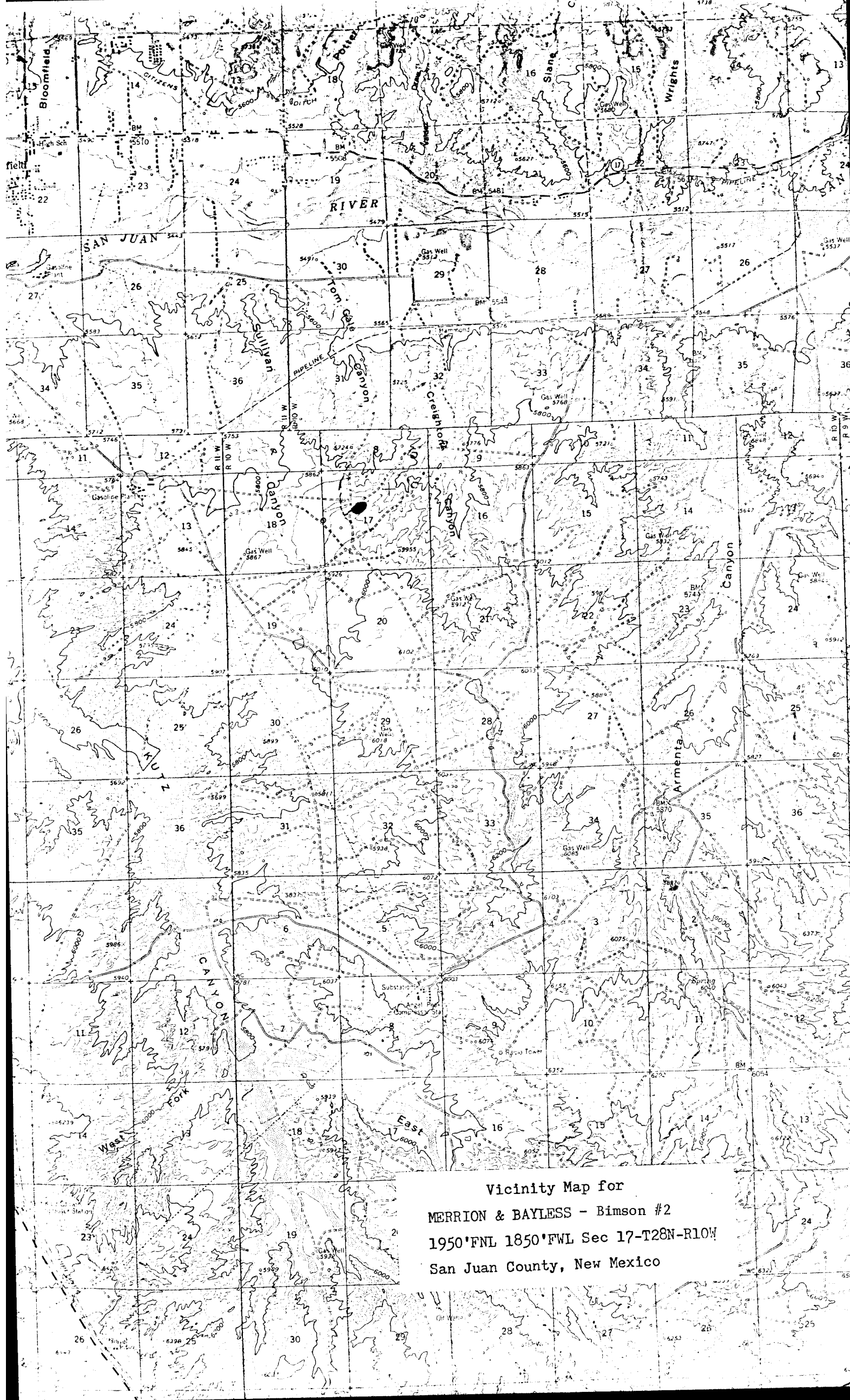
