13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Move in service unit. Pull 1.90" production string. Run and set bridge plug at 1000' w/2 3/8" work string. TOH w/tubing. Run in well and perforate at 950'. Set retainer at 875'. Open bradenhead valve and attempt to establish circulation. If circulation is established, pump 20 Bbls of chemical wash 275 sks 65/35 GiPoz w/6% gel. Yield 1.79, weight 12.7#. Tail in w/50 sks G Neat. Weight 15.8# yield 1.18 cu ft/sk. Displace to top of retainer. If circulation cannot be established. Squeeze using 50 sks G Neat. Weight 15.8# yield 1.18 cu ft/sk. TOH w/tubing. Let squeeze set for 24 hrs. Drill out cement. Pressure test casing to 1000 psi. Retrieve bridge plug. Run production tubing. Put well on line. Continue monitoring bradenhead.
