This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde Pool.

It is intended to locate the El Paso Natural Gas Company's Hancock #2A at 1025' from the South line and 530' from the East line of Section 29, T-28-N, R-9-W, San Juan County, New Mexico.

Extremely rough terrain in the form of steep cliffs in the southeast corner of this section makes it impossible to build an orthodox gas well location.

El Paso Natural Gas Company is the offsetting operator of the surrounding area.

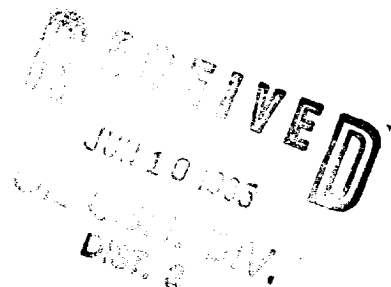
Plats showing the proposed well location and the terrain in Section 29, along with an ownership plat, are attached.

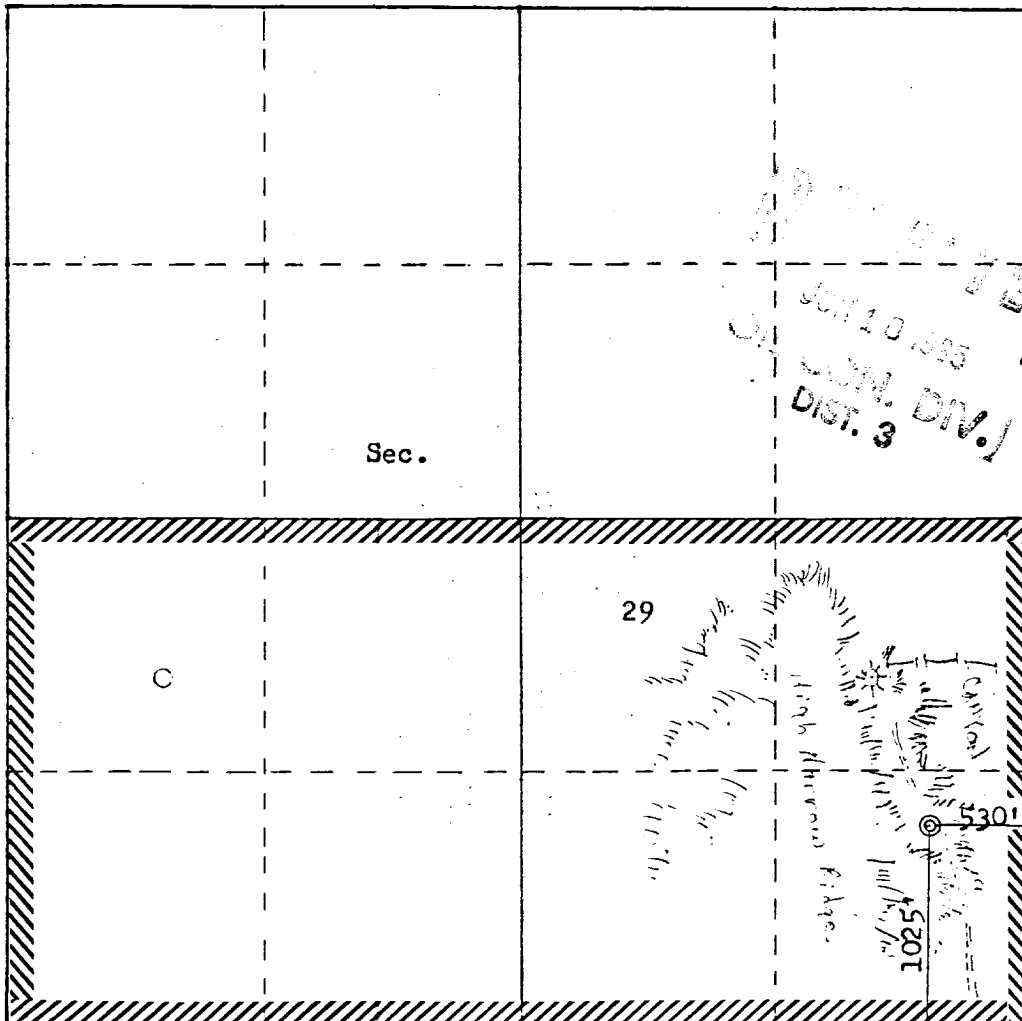
