9-9-85 TD 5400'. Ran 66 jts. 7", 23.0#, N-80 casing 2803' set @ 5400'. Cemented with 520 sks. Class "B" 50/50 Poz, with 2% gel, 6.25# gilsonite, 1/4# celoflake, 0.6% FLA (707 cu.ft.) WOC 12 hours. Held 1200#/30 minutes. Circulated cement to surface.

9-10-85 TD 7085'. Ran 44 jts. 4 1/2", 11.6#, N-80 casing liner, 1789' set @ 7085'. Float collar set @ 7078'. Top of liner at 5296'. Cemented with 95 sks. Class "B" 8% gel and 1/4 cu ft fine gilsonite (206 cu ft) and 100 sks. Class "B", 1/4 # fine tuf-plug/sk, 4% FLA (118 cu.ft.) WOC 18 hours.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
