Cross Timbers Operating Co. spudded the above mentioned well on 10/3/00 @ 1:15 p.m.

Cross Timbers set 5 jts of 7", 20.0#, J-55 surface casing @ 225' on 10/3/00 @ 8:00 p.m. The surface casing was cement with 75 sx of cement w/2% CaCl₂ & 1/4#/sx celloflake mixed @ 15.6 ppg & 1.18 cuft/sx. 4 bbls (22 cuft) of good cement was circulated back to surface.

On 10/4/00 the BOP's were installed and pressure tested to 250/1,000 psig (held OK) and drilling resumed.
