2. Log well from casing shoe to surface to locate Fruitland Coal interval.
3. Plug back with CIBP @ approximately 1356'.
4. Perforate the Fruitland Coal w/ 4 JSPF.
5. Fracture stimulate with a minimum of 40,000# of sand.
