



No returns. Let set 4 hrs. Checked cement top at 80'. Ran 80' - 2" line pipe. Mixed 100 sacks regular cement with 2% CaCl₂. Filled annulus. Completed at 1:00 AM 7-20-60. WOC 12 hrs. Pressured casing with 800# for 1/4 hr. OK.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.



1. *Staphylococcus aureus* (ATCC 12228) was grown in Tryptone Soy Broth (TSB) (Difco) at 37°C. Cells were harvested at mid-log phase (OD₆₀₀ = 0.5) and washed with phosphate buffered saline (PBS) (pH 7.4). Cells were then resuspended in PBS and sonicated using a Branson 250 sonifier (Branson Ultrasonics, Danbury, CT) for 10 min. The cell suspension was then centrifuged at 14,000g for 10 min and the supernatant was removed. The pellet was resuspended in PBS and sonicated for 10 min. The supernatant was removed and the pellet was resuspended in PBS. The final supernatant was then dialyzed into PBS (pH 7.4) using a dialysis membrane (MWCO 10,000) (Dialysis Membrane, Spectrum Laboratories, Inc., Rancho Dominguez, CA). The dialysate was then concentrated using a Centricon 30 ultrafiltration membrane (Amicon, Beverly, MA) to a final volume of 1 mL. The concentrated sample was then stored at -80°C.
