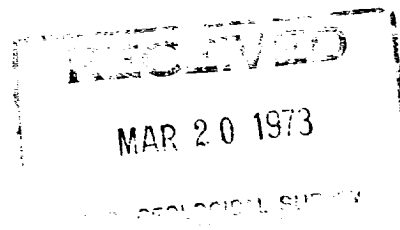

On March 13, 1973, the Gallegos Canyon Unit No. 253 was plugged and abandoned with Class "A" cement as follows:

1. Spotted 50 sacks at 5627'.
2. Squeezed 20 sacks into formation thru perforations 5546-5564'.
3. Spotted 20 sacks at 4300'.
4. Spotted 20 sacks at 3200'.
5. Spotted 20 sacks at 2538'.
6. Spotted 20 sacks at 1706'.
7. Spotted 20 sacks from 256' to surface.
8. Cut off wellhead and erected PXA marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
