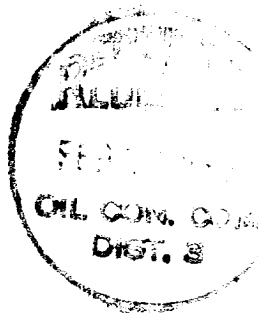

With hole full of drilling mud, set cement plugs as follows: 80 sacks from 4960' to 4650', 32 sacks from 3500' to 3400', and 77 sacks from 800' to 550'. Cut off wellhead and spotted 10 sack cement plug in top 8-5/8" casing. Cemented 4-1/2" pipe marker in top of hole. Completed plugging 2/21/68.
