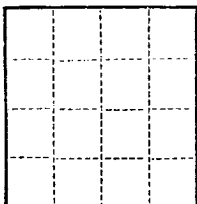

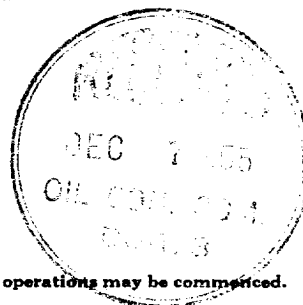

### DETAILS OF WORK

Propose to drill to 175' run 9-5/8" casing, cemented w/ 125 sz 4 1/2 gal. Drill to 3400' with water or minimum mud. Set 7" casing cemented with 150 sz 2 1/2 gal w/ 50 sz bent. Then drill to 5720' (total depth) set 5" casing. Cemented with 200 sz 2 1/2 gal. Perf. and Free Point Locust, Monafee and Cliff House separately each with 40,000 gal. w/ approx. 1 1/2 sz/gal. Run tubing and complete well.

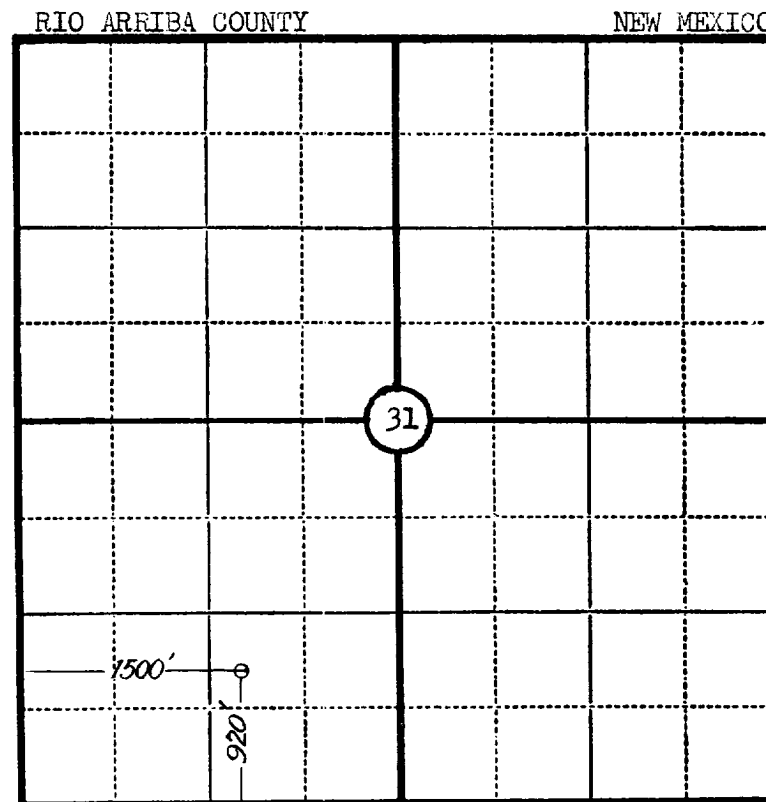

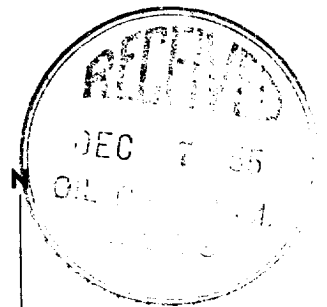

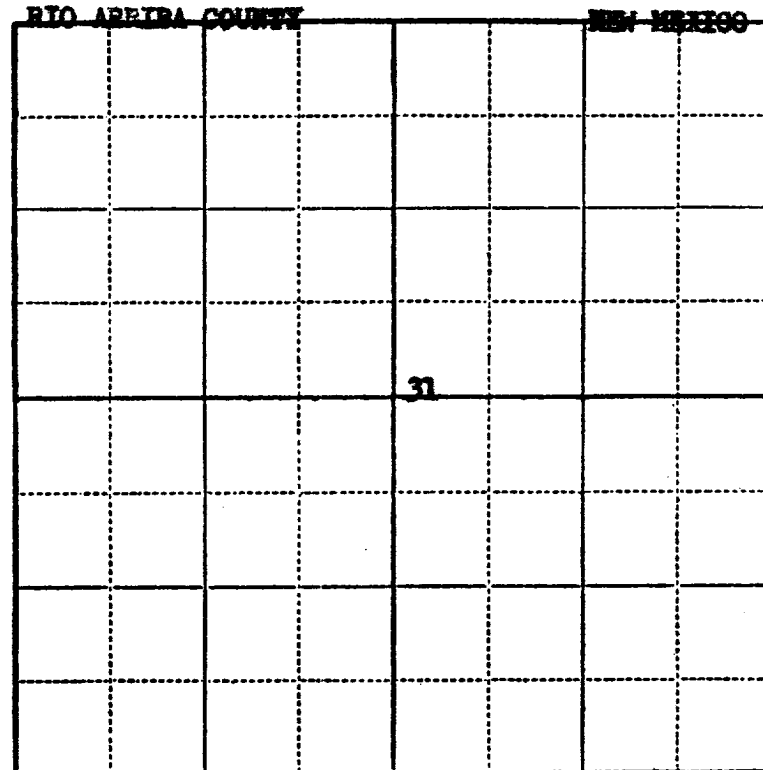
