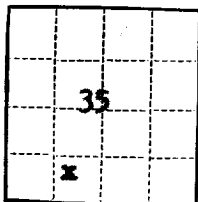

DETAILS OF WORK

Propose to drill to 200' and set 10-3/4" casing, cement to surface. Set 7-5/8" casing @ 3550', cement w/150 sx 8% gel and 50 sx neat. Set 5-1/2" liner @ 5690', cement w/150 sx reg.

Mesa Verde to be fractured thru perms using approx 150,000 gals water, clean out to total depth, set tubing and complete well.

The W/2 of Section 35, containing 320 acres, is dedicated to this well.

37 1/2% Pacific Northwest, 50% El Paso Natural Gas, 12 1/2% Wood River Oil.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
