RIH w/bit & tagged fill @ 4550'. C/O to CIBP @ 4950'. Milled through CIBP @ 4950' and then CIBP @ 7550'. Cleaned out debris to PBTD @ 7764'. Circ. hole. RIH w/2-3/8" 4.7# J-55 tubing and set @ 7701' with "F" nipple set @ 7669'. ND BOP & NU WH. PT - OK. Pumped off expendable check. RD & released rig to first deliver well as commingled. Production from MV & DK was commingled on 1/11/01.
