On 9-11-69 located hole in 7" casing (2754-4766') set cement retainer at 2572', squeezed hole w/200 sacks of cement.

On 9-15-69 Sidetrack T. D. 6066', ran 190 joints 4 1/2", 10.5#, K-55 casing (6076') set at 6066' w/125 sacks of cement. W.O.C. 16 hours.

On 9-16-69 F.B.T.D. 6051', perf. 5720-34', 5744-60', 5770-76', 5814-22', 5842-52', 5862-70' w/20 SPZ. Sand water frac w/70,000# 20/40 sand, 69,930 gal. water, flushed w/3990 gal. water, dropped 5 sets of 16 balls. Set bridge plug at 5566', tested to 3000# O. K. Perf. 5290-5300', 5310-16', 5326-34', 5346-56', 5370-60' w/20 SPZ. Sand water frac w/40,000# 20/40 sand, 48,132 gal. water, flushed w/3612 gal. water. Dropped 4 sets of 20 balls.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
