In January 1997 the Lewis Shale pay was added to the existing Mesaverde interval. A packer and sliding sleeve were placed in the tubing across the Lewis Shale interval for testing. The packer and sliding sleeve have now been removed. Details are as follows:

5/29/98

MIRU Big A #29. Closed sliding sleeve and set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and COOH. RIH w/2-3/8" tubing and cleaned out to 5505'. Landed tubing @ 5424' with "F" nipple set @ 5391'. ND BOP & NU WH. Pulled BPV and PT to 750 psi. Pumped off check. RD & MO. Turned well over to production department.
