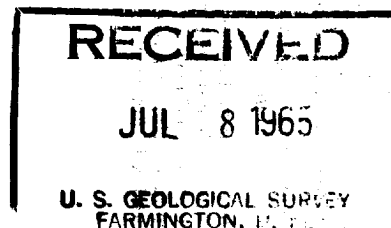

Instructions
