DETAILS OF WORK

It is intended to drill a well with rotary tools thru the Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. Gas circulation will be used thru the Mesa Verde and production liner will be set. Possible productive intervals will be perforated and fractured. Est. T. D. 5600'.

Casing Program:

- 10 3/4" @ 120' w/110 sacks cement circulated to surface.
- 7 5/8" @ 3525' w/170 sacks cement to cover Ojo Alamo.
- 5 1/2" @ 5600' w/225 sacks cement to cover top of liner.

The E/2 of Section 20 is dedicated to this well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

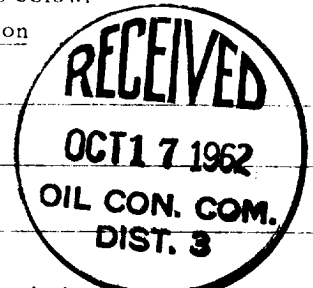

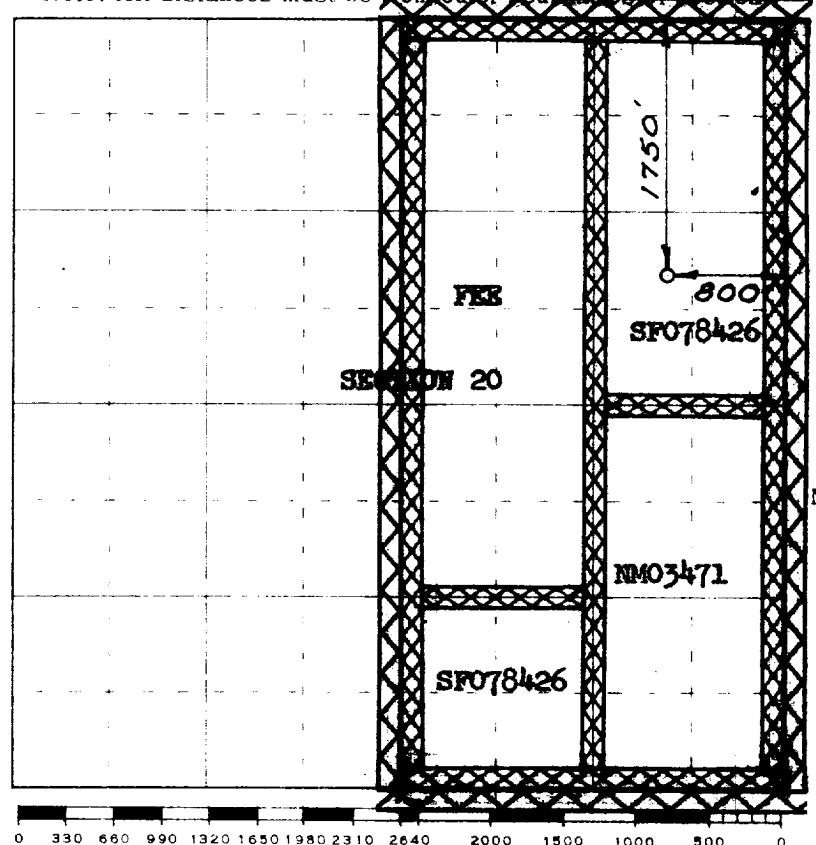
