The subject well had the Lewis Shale interval within the Mesaverde formation completed in April 1999. The CIBP was left in to test the Lewis Shale. The CIBP has now been removed and all Mesaverde production commingled. Details of work done as follows:

9/1/99

MIRU Key Energy #29. Kill well w/2% KCL. ND WH & NU BOPs. PT - OK. COOH w/2-3/8" tubing. RIH w/4-3/4" bit & cleaned out fill to 5400'. Drilled out CIBP @ 5400'. Circulated bottoms up. Cleaned out fill to 6014' (PBTD). COOH. RIH w/2-3/8" tubing and landed @ 5907' with "F" nipple set @ 5875'. ND BOP & NU WH. PT - OK. Pumped off check and RD & released rig 9/2/99. Turned well back over to production department.
