8/2/00 MIRU Key Energy #40. Kill well. ND WH & NU BOP. PT-OK. Unset tubing hanger & COOH w/tubing. RIH w/scraper to 7800'. Set CIBP @ 7800'. Load hole & PT casing & CIBP to 500#. Good test. Ran GR/CCL/CBL from 7752' - surface. RU to squeeze cement behind pipe @ MV interval. Shot 3 squeeze holes @ 5344'. RIH w/4-1/2" cement retainer & tubing to 5289'. Pumped though retainer 300 sx C1 H cement. Stung out of retainer. RIH w/3-7/8" bit to 5200'. WOC. Tagged up @ 5289'. Drilled out cement retainer. Circ. hole. PT squeeze holes to 600# - OK. POOH. Ran CBL. Cement from 5480' - 5150'. RU to perforate MV interval @ 1 spf .34" holes as follows

RIH & cleaned out fill to 7750' (CIBP still @ 7800'). COOH. RIH w/2-3/8" 4.7# tubing & set @ 5763' with "F" nipple @ 5729'. ND BOP & NU WH. Pumped off check. RD & released rig 8/10/00. Producing MV interval only.
