Pumped 200,000 # 20/40 Sand w/60 Quality foam. ATP-2150#, ATR-45 bpm. ISDP - 755 #. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/bit & drilled out CIBP @ 5075', then CIBP @ 7750'. Circ. hole & cleaned out to PBTD @ 7970'. RIH w/2-3/8", 4.7# tubing and set tubing @ 7903' with "F" nipple set @ 7802'. RD & released rig 12/23/00. Turned well over to production department to first deliver well as commingled. Production from MV & DK was commingled on 12/26/00.
