On 8-17-70 cut off stuck tubing at 4870', pulled tubing and set a cement retainer at 4655', squeezed open hole w/150 sacks of cement.

On 8-18-70 Perf. 2 squeeze holes at 2235', set cement retainer at 2111', squeezed through perfs w/125 sacks of cement.

On 8-23-70 T. D. 5541', ran 170 joints 4 1/2", 10.5#, K-55 production casing (5531') set at 5541' w/125 sacks of cement. W.O.C. 18 hours.

On 8-24-70 P.B.T.D. 5528'. Perf. 5282-88', 5300-12', 5322-34', 5364-70', 5392-5404', 5414-20', 5448-54' w/18 SPZ. Frac w/76,000# 20/40 sand, 77,070 gal. water, dropped 4 sets of 18 balls, flushed w/3402 gal. water. Pumped bridging ball to baffle at 5066', tested to 3000# O. K. Perf. 4824-30', 4842-48', 4866-78', 4906-18' w/18 SPZ. Frac w/25,000# 20/40 sand, 28,128 gal. water, dropped 2 sets of 18 balls. Well sandbed off after second ball drop. No flush.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
