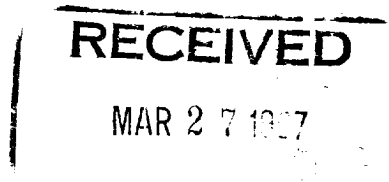

On 2-12-67 T. D. 505', ran 16 joints 13 3/8", 46#, H-40 surface casing (288') set at 502' w/500 sacks cement circulated to surface. W.O.C. 18 hours. Tested w/500#/30 Min. O. K.

On 3-4-67 T. D. 3757', ran 94 joints 9 5/8", 36#, J-55 casing (3742.37') set at 3755.57'. Second stage tool set at 2506'. Cemented first stage w/150 sacks cement, second stage w/850 sacks circulated. W.O.C. 18 hours. Tested w/1000#/30 Min. O. K.

Instructions
