In February 1997 the Lewis Shale pay was added to the existing Mesaverde interval. A packer and sliding sleeve were placed in the tubing across the Lewis Shale interval for testing. The packer and sliding sleeve have now been removed. Details are as follows:

MIRU Big A #29. Closed sliding sleeve and set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and COOH w/packer and sliding sleeve. RIH w/2-3/8" tubing and landed @ 5853' with "F" nipple @ 5820'. ND BOPs and NU WH. PT tubing. Pump off check. RD & MO. Turned well over to production department.
