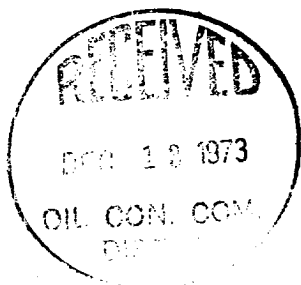

Well spudded 11-16-73. Drilled 15" hole to 515', set 10 3/4" 40.5# casing landed at 512', and cemented with 500 sacks Class "A" cement with 2% CaCl₂ - cement returns to surface. Bumped plug at 9:30 p.m. 11-17-73 with 800 psi.
