MIRU. ND WH & NU BOPs. POOH w/production tubing. Isolate existing Mesavearde perfs with bridge plug. PT casing. If casing fails test - isolate failure. Remediate with cement.

If well records indicate no cement across Lewis Shale interval, it may be necessary to run a casing bond log (CBL). Shoot squeeze holes in the casing and pump sufficient volumes of cement to cover and isolate the Lewis Shale.

Perforate and stimulate the Lewis Shale (perfs to be determined after logs are run). Retrieve bridge plug and run production tubing. Flow test the Lewis Shale.

A workover pit may be required.
