MI & RU Dowell coiled tubing unit. SI 2-7/8" master valve & installed new tree. Installed .75" profile nipple on bottom of 1-1/4" coiled tubing. Bleed down pressure to steel pit. RIH w/tubing and tagged fill on bottom @ 3727'. Pulled up to 3700'. Kill tubing annulus w/2 bbls of 2% KCL H2O. Pull flange off tree & set tubing slips. Cut off coiled tubing. Thread tubing stub & installed 1" ball valve. Bottom of tubing set # 3700' & .75" profile nipple @ 3699'. RD & release tubing unit. Turned well back over to production department.
