Temporary Abandonment Report

Cementing Summary:

Plug #1 with CIBP at 8674', spot 12 sxs cement above CIBP up to 8516' to isolate the Dakota perforations.

Plug #2 with 13 sxs cement inside casing from 7461' to 7290' to cover Gallup top.

TA Work Summary:

Notified BLM on 5/02/02

5-02-02 MOL. Held JSA. Put down plastic and spot rig in, RU. Layout relief lines to pit. Bow down 820# on 4-1/2" casing pressure and 490# on 7" intermediate. Pump 40 bbls down tubing to kill well. ND wellhead. NU BOP and test. PU on tubing and remove tubing hanger. TOH and tally 139 stands 2-3/8" EUE tubing with F-nipple and 1 joint with notch collar, total 8708'. Shut in well. SDFD.

5-03-02 Held JSA. Open up well and blow down 60# on 7" intermediate pressure. RU A-Plus wireline truck. Round-trip 4-1/2" gauge ring to 8700'. Set 4-1/2" PlugWell CIBP at 8674'. TIH with tubing and tag CIBP at 8674'. Load casing with 40 bbls of water and circulate well clean with total of 135 bbls of water. Pressure test casing to 875# with pen-recorder and chart. Note the 7" intermediate casing and bradenhead were open, no blow. TOH with tubing. Shut in well. SDFD.

5-06-02 Held JSA. RU Blue-Jet wireline and run CBL. Top of cement is at 4810'. Run GSL neutron log. RD Blue-Jet. TIH with tubing and tag CIBP at 8674'. SI well & SDFD.

5-07-02 Held JSA. Open up well. Blow down 40# pressure on 7" intermediate casing. Plug #1 with CIBP at 8674', spot 12 sxs cement above CIBP up to 8516' to isolate the Dakota perforations. PUH to 7461'. Plug #2 with 13 sxs cement inside casing from 7461' to 7290' to cover Gallup top. PUH to 7272' and reverse circulate hole clean with 60 bbls water. TOH and LD tubing. Fill 4-1/2" casing with fresh water. NU wellhead. Pressure test 4-1/2" casing to 850# with chart for 30 minutes. RD. MOL.
