12/18/97 MIRU Big A #18. ND WH & NU BOPs. Test - OK. Killed well. COOH w/production tubing and packer. RIH with the following.

2-7/8" tubing set @ 3131.45'
2-7/8" "R" nipple set @ 3100.29'
7" Lok-set Packer top @ 2877.71'; bottom packer @ 2883'
On/off tool @ 2872'.
2-3/8" sub @ 2870' w/2-3/8" tubing to surface.

ND BOPs & NU WH. PT - OK. RD & MO 12/21/97. Return well to production.
