GIH w/96 jts tbg w/RBP & set. load casing w/H₂O. PT Annular to 3000 #. COOH w/96 jts 2-3/8" tbg. NU Isolation Tool. MI Western, NU lines. Frac'd well Fruitland Coal Interval 3172' - 3282' down 7" csg. 756 bbls (30#/1000 gal) gelled fluid, 1,575,428 scf-N₂ @ 60% quality, 151,280 lbs of 16/30 Brady Sand ramped from 1 to 4 ppg. Flushed w/94 bbls of gelled water. Max pres 4500 psi, Avg pres 4200 psi. Ave rate 75 BPM, ISIP 4150 psi. Immediate flow back for forced closure. Flowed well back thru choke manifold thru open 2" for 1 bbl/min. w/2% KCl. Flowed well back thru choke manifold, thru 1/8" fixed choke @ 1-2 BPM. Open up well thru 2" to bleed off well. Snub out isolation tool. Blow down well 1300 psi, bleed off slowly. Cleaned well with air, H₂O & soap sweep. GIH w rest of tubing and landed at 3061.15'. Gas Sandrell @ 2206.65'. ND BOP NU WH. Pump off exp check. RD & released rig. Flow tested 195 mcf @ tubing pressure 110 psi with 1/4" choke.
