Mixed and pumped 350 sx (413 cu ft) Class B containing 3% CaCl2 + 1/4#/sx cellophane @ 5-BPM. Circ. 16 bbls (76 sxs) to surface. Plug down @ 23:00 6-20-95. WOC. NU WH & BOPs. Pressure test - Good tests.
