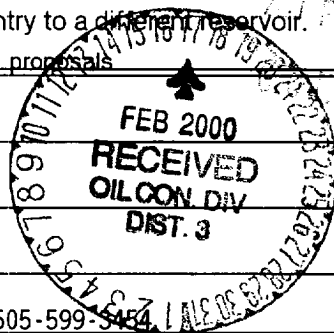

The Pt. Lookout, Merifree and Cliffhouse intervals have been completed & tested. We have now removed the CIBPs between each interval and will commingle all of the MV zones. Below are details of the work done to remove the CIBPs.

1/26/00 MIRU Key #18. ND flowback equipment & NU BOPp. PT - OK. NU to run 2-3/8" tubing. Kill well w/30 bbls clay stabilized water. GIH w/mill & cleaned out fill to #1 CIBP @ 5072'. Drilled out CIBP. GIH & tagged sand above #2 CIBP. Cleaned out fill to 5365'. Drilled out #2 CIBP. RIH & cleaned out fill to PBTD @ 5750'. COOH w/mill. Ran slickline & ran GR-protectics log from 5640' - 4750'. RIH w/2-3/8" 4.7# tubing and cleaned out to PBTD. Landed tubing @ 4904' with "F" nipple set @ 4871'. ND BOP & NU WH. PT - OK. Pumped off check. RD & released rig 02/02/00. Turned well over to production department.
