ATP - 2600 pai, ATR - 45 bpm. Total of 1,300,900 scf N2. ISIP - 1800 psi. Flowed back on 1/4" and 1/2" chokes for 44 hours. RD flowback equipment. ND BOP & PT - OK. Killed well w/water. RIH w/2-3/8" 4.7# tubing and set @ 5210' with "F" nipple set @ 5177'. ND BOP & NU WH. PT - OK. Pumped off expendable check. RD & released rig 5/22/00. Will flow Menefee interval until pressures stabilize and then will add rest of Mesaverde intervals before removing CIBP between Dakota and Mesaverde intervals and commingling.
