12/21/01. MIRU Key #18. COOH w/rods and stroke pump. ND WH & NU BOP. PT-OK. COOH w/tubing. RIH w/mill & tagged top of 3-1/2" liner @ 8224'. COOH w/mill. RIH w/CIBP and attempted to set. Unsuccessful. COOH w/BHA, lost CIBP. RIH w/slickline & pushed CIBP to bottom. NU & land hanger. ND BOP. RIH w/2-1/16" tubing and set @ 8211' w/PPC-070-pump set @ 8202', X-over set @ 6701' and then 2-3/8" tubing set to surface. Installed pump rods for pump. PT tubing & pump to 500 psi. RD & released rig 1/2/01.

We had permission to work on this well during the winter closure period, but we were unable finish correcting the problem in the time allotted us to be in and out. The well was returned to the production department and plans are to return after the restriction period & attempt again to set a CIBP to isolate that portion of the DK interval producing the excess water.
