RIH w/RPB & packer & set @ 5353'. PT-OK. Acidized perfs w/1500 gal 15% HCL. Released packer & RBP. COOH. RU to frac. Pumped 70 Quality 20# Linear foam - pad = 34000 gal & Treatment fluid = 100,228 gal which included 100,900# of 20/40 sand. Flowed back on 1/4" and 1/2" chokes. RD flow back equipment. RIH w/tubing and cleaned out to RPB @ 5720'. COOH. RIH w/2-1/16" tubing & set @ 5516' and "F" nipple set @ 5486'. RD & released rig 5/2/01. Turned over to production to flow MV only. Will return at a later date and c/o CIBP @ 5720' and commingle DK and MV production.
