Pumped 10 bbls H2O, 10 bbls mud clean and then 10 bbls dye water. Then pumped Lead - 490 sx (1166 cf-207.65 bbl slurry) Type 3, 35:65 POZ, 6% Bentonite, 0.25#/sx Cello-flake, 5#/sx Gilsonite, 10#/sx CSE, 3% KCl, 0.4% FI-25, 0.02#/sx Static Free. Then Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced with 161 bbls water. Plug down @ 0022 hrs 1/3/01. Circ. 8 bbls cement to surface. ND BOP. Set slips and cut off casing. PT - OK.
