Acidized perfs w/1500 gal 15% HCL. RU to frac. Pumped 30,534 gal of slick H2O foam consisting of 20,100 gal of slick H2O & 880,090 scf N2. Pumped a 7980 gal foam pad followed by 22,554 gal of slickwater containing 79,880# 20/40 proppant. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment and turned well over to production to flow test the MV interval only. Will return within 60 days to add the Lewis Shale interval of the Mesaverde.
