Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3 cement, 1% CaCl2, 1/4#/sx Cello-flake. Displaced w/147 bbls H2O. Plug down @ 2130 hrs 8/25/00. Float held. Had 15 bbls cement circulated to surface.

ND BOP, set slips and cut off casing. NU BOP & manifold. PT rams, casing and manifold.
