8/9/00 MIRU Key Energy #32. NU Manifold. Kill well w/60 bbls 2% KCl. ND WH & NU BOP. PT - OK. RIH w/2-3/8", 4.7# tubing & set @ 5945' with "F" nipple set @ 5910'. ND BOP & NU WH. Pumped off expendable check and RD & released rig. Returned well to production.
