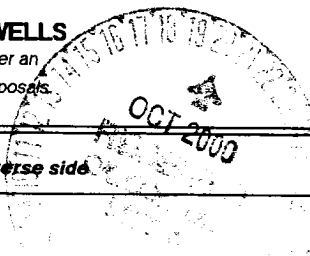

With 8-3/4" bit & drilled ahead to 3780'. Circ. hole. RIH w/7", 20#, J-55 casing and set @ 3780'. RU BJ to cement. Pumped lead cement - 500 sx (1250 cf - 222.61 bbl slurry) Type 3 35:65 POZ, 5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% Bentonite, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static free.

Pumped tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 1/4#/sx Cello-flake, Displaced w/151 bbls FW. Circ. 10 bbls (56 cf) cement to surface. Plug down @ 0515 hrs. 8/8/00. ND BOP, set slips and cut off casing. NU BOP & manifold. PT - BOP. Plug & manifold to 250#, then 3000#. Good test.
