6/29/00 MIRU Key #18. NU BOP. PT-OK. RIH w/3-7/8" bit & tagged up @ 4167' (60' cement above DV tool). Drilled out cement & DV tool, then cement above & shoe @ 6960'. C/O hole from 6960'-7733'. COOH. RIH w/3-1/2" 9.3# liner & set @ 7733' with top set @ 6759'. Pumped 10 bbls mud clean, 10 bbls gelled water & 10 bbls gel w/red dye & 5 bbls FW ahead of cement. Pumped 100 sx 35/65 C1 H POZ w/6% gel, 10#/sx CSE, 0.3% CD-32, & 0.7% FL-52 2 2.12 yield (212 cf). Dropped plug & displaced w/37.5 bbls FW @ 1440 hrs 7/3/00. Circ. gelled water, but no cement. Load casing w/20 bbls FW & PT to 1700 psi, Slow leak. RU to squeeze liner top. Pumped 30 sx C1H cement w/0.3% FL-52, 2% Sodium Metasilicate, w/0.3% CD-32 (35 cf). Reversed 3 bbls cement. Pulled up 1 stand to 6390' & hesitate & squeeze 1.8 bbl cement in 1/4 bbl increments. Finished @ 1833 hrs 7/5/00. RD. WOC.

COOH. RIH w/3-7/8" bit & tagged top of cement @ 6538' (220' cement above liner lap top @ 6758'). D/O cement to 6758'. PT liner lap to 500 psi (30 minutes). Good test. COOH w/bit & scraper.
